

Certified Professional Counselors Supervisor (CPCS) Credential

REQUIRED SUPERVISION TRAINING

Total hours for initial approval: 24 CEs

Hours required every 2 years for renewal: 12 CEs

Required content areas:

1. ***Legal and Ethical Issues in Supervision*** — 6 hours minimum for initial application and 3 hours minimum in subsequent renewals
2. ***Foundations of Supervision*** — 6 hours minimum for initial application
3. ***Methods of Supervision*** — 6 hours minimum for initial application
4. ***Specialized/Advanced Techniques in Supervision***—no required hours in this category, but hours may be included from this category if other required content areas have been met
